Important information about this document

This target market determination (**TMD**) has been prepared by the Company in relation to the following offers pursuant to the Company's prospectus (available at www.aurumin.com.au/investors/asx-announcements/) dated 17 April 2023 (**Prospectus**):

- (a) an offer of up to 19,000,000 free attaching options exercisable at \$0.06 each and expiring 31 August 2024 (**Quoted Options**) in connection with a placement to sophisticated and professional investors qualifying under s708 of the Corporations Act announced to ASX on 9 March 2023 (**Placement**);
- (b) an offer of up to 98,879,107 Quoted Options in connection with an entitlement offer; and
- (c) an offer of up to 30,000,000 Quoted Options in connection with lead manager and underwriting services provided and to be provided by GBA Capital Pty Ltd (ABN 51 643 039 123) (**GBA**).

Capitalised terms used, but not defined, in this TMD have the meaning ascribed to them in the Prospectus.

Pursuant to the Prospectus:

- (a) Participants in the Placement are being offered 1 Quoted Option for every 1 new Share subscribed for (subject to Shareholder approval at the General Meeting);
- (b) Eligible Shareholders who apply for Shares under the Entitlement Offer and Top-Up Offer are being offered 1 Quoted Option for every 1 Share subscribed for under the Entitlement Offer and Top-Up Offer;
- (c) New Investors who apply for Remaining Shortfall Securities under the Shortfall Offer are being offered 1 Quoted Option for every 1 new Share subscribed for under the Shortfall Offer; and
- (d) GBA is being offered up to 30,000 Quoted Options as partial consideration for lead manager services pursuant to the Placement Mandate (in the amount of 5,000,000 Quoted Options), the Entitlement Mandate (in the amount of a further 5,000,000 Quoted Options) and underwriting services pursuant to the Underwriting Agreement (in the amount of a further 20,000,000 Quoted Options), subject to Shareholder approval at the General Meeting (failing which the Company will pay the Underwriter the cash equivalent of the same determined utilising a Black & Scholes valuation of the Quoted Options),

(collectively, **Quoted Option Offer**).

Any recipient of this TMD should carefully read and consider the Prospectus in full and consult their professional adviser if they have any questions regarding the contents of the Prospectus. Any

recipient of this TMD who wants to acquire Quoted Options under the Quoted Option Offer will need to complete the Application Form. There is no cooling off period in respect of the issue of the Quoted Options. This TMD is not a disclosure document for the purposes of the Corporations Act, and therefore has not been lodged, and does not require lodgement, with ASIC.

This TMD does not take into account what you currently have, or what you want and need, for your financial future. It is important for you to consider these matters and read the Prospectus before you make an investment decision. The Company is not licensed to provide financial product advice in relation to the Quoted Options.

| Investment Objective | <p>The Company expects that an investment in Quoted Options will be suitable to investors who wish to gain exposure to equities in a small/mid-cap mining company listed on the ASX.</p> |
| Investment Timeframe | <p>The target market of investors will take a short to medium term outlook on their investment. The Company will apply for quotation of the Quoted Options subject to compliance with the requirements of ASX and the ASX Listing Rules.</p> <p>To the extent the Quoted Options are quoted on ASX's official list, subject to any restriction or escrow arrangements imposed by ASX or under Australian securities laws, the Quoted Options will be freely transferable from the date of issue, subject to any restriction or escrow arrangements imposed by ASX or under Australian securities laws.</p> <p>However, investors (particularly those with a short-term outlook for their investment) should be aware that, to the extent the ASX conditions to quotation are not satisfied, the Quoted Options will be Unquoted Options. | Risk | <p>The Company considers that, while the issue price of the Quoted Options is free, an investment in the Company offered in connection with the Prospectus (for example, through the exercise of the Quoted Options) should be considered highly speculative, such that an investment in the Company is not appropriate for an investor who would not be able to bear a loss of some or all of the investment. | Review Triggers | <p>The Quoted Options are being offered for a limited offer period set out in the Prospectus, after the conclusion of which the Quoted Options will no longer be available for investment by way of issue.
